The review period saw Russian consumers developing a taste for unique furniture and furnishings which were designed and manufactured after the customer placed an order to suit his personal needs, room design and size. The boom in mortgages and number of transactions in real estate in 2009-2012, years when real estate prices experienced turbulence, also forced consumers to make interior design changes more frequently which allowed the channel to register current value growth of 12% in 2012.
