Abstracts

Furniture and homewares stores recorded 3% growth in 2012 to reach sales of €550 million. Growth was generated predominantly from the overall increase in unit prices. Comparing 2012 growth to the performance in the previous year, only a marginal improvement was recorded. In 2012 two stores closed leaving an overall 917 outlets still in operation.
