## Abstracts

In 2022, the impact of inflation was evident in various areas of the market, including processed meat and processed seafood. Both of these categories experienced a decline in retail volume terms, while seeing healthy growth in current value terms. However, within these categories products showed uneven behaviour. For instance, shelf stable meat and seafood suffered the most significant declines in retail volume terms which was largely due to the high prices of items like jam and smoked salmon.
