RTDs/high-strength premixes recorded lower growth in 2017 than the previous year due to a colder summer than usual, with sales of RTDs in particular being weather sensitive. Furthermore, increased cross-border trade with Sweden limited growth, not unique to RTDs/high-strength premixes but having an overall effect on alcoholic drinks in Norway. Lastly, more competition from a new wave of liqueur products that have a similar target consumer group as RTDs, so-called "candy-shots", had a negative ef...
