RTDs/high-strength premixes in Poland continued to experience a strong decline in 2017. At least four brands including Gate and Jack Daniel's were discontinued and are no longer available in Poland. At the end of the review period, there was a limited number of brands that could be found in drinks specialists such as Bacardi Breezer and Sobieski Impress. Discounters tend to only offer private label lines, rather than offering competitive brands. Lack of consumer attention is mainly caused by los...
