Domestic tourism slowed down in 2013 mainly due to the 7.2 magnitude earthquake which hit Cebu and Bohol on 15 October and super typhoon Haiyan which battered Eastern Visayas on 8 November. The period at which the two calamities hit the country had a strong impact on domestic tourism since travels peak towards the end of the year, especially as families go on trips during the Christmas break. As a result, the number of domestic trips in 2013 registered slower growth of 4% compared to the 11%...
