In 2012, travel accommodation recorded current value growth of 20% due to a positive economic environment that enabled higher expenditure on domestic and inbound tourism. The high point of 2012 was one of the reasons behind the small decrease in 2013. Another reason was the flat growth of inbound tourism trips in 2013.
