The main difference between ISO 14001 and OHSAS 18001 is that:

ISO 14001 focuses on managing your organization's impact on the external environment, to reduce pollution and comply with regulations

OHSAS 18001 focuses on managing your organization's internal environment to ensure a safe and healthy workplace.

Structurally, the two standards are the same and the requirements are very similar. Consequently, the processes and documentation needed to implement and certify to ISO 14001 and OHSAS 18001 are essentially the same. Only the intent and focus are different.
