The global 3D printing filament market is expected to increase by USD 1,056.0 million, at a compound annual growth rate (CAGR) of 17.9% from 2022 to 2028, according to the latest edition of the Global 3D Printing Filament Market Report.

The stainless steel segment captured the largest share of the market in 2021 and is expected to maintain its dominance during the forecast period. Furthermore, the plastics market has been categorized into acrylonitrile butadiene styrene (ABS), nylon, polyethylene terephthalate (PET), polylactic acid (PLA), others. According to the research, the PLA segment had the largest share in the global 3D printing filament market.
