Avobenzone is the most important UVA absorber that has been globally approved. Avobenzone (EU) (formally 4-tert-butyl-4'-methoxydibenzoylmethane, or butyl methoxydibenzoylmethane) was patented in 1973 and commercialized by Hoffman LaRoche as Parsol 1789. It was approved as a monographed sunscreen in the EU (up to 5%) in 1978 and by the FDA (up to 3%) in 1996. It is an oil-soluble, crystalline UVA sunscreen (EU) with a melting point of 81-86 C. Avobenzone has an absorption maximum of 357 nm and a UV absorption value (1% / 1 cm in methanol (EU) at 358 nm) of 1100 – 1160.
