Contract manufacturing is a business model where a company hires a manufacturer to produce its products or components. It is an outsourcing method for producing products by taking advantage of the resources and expertise of an experienced manufacturer for the benefit of the contracting company. Contract manufacturing uses the customer's own formula (recipe) and follows processing methods agreed upon by the customer and the manufacturer. The bakery and its customer usually sign confidentiality agreements protecting each other's interests. The global bakery contract manufacturing market size is projected to grow by USD 16.1 billion from 2023 to 2029, registering a CAGR of 9.3 percent, according to the latest market data.
