According to Gen Consulting Company, the global behavioral rehabilitation market is set to achieve an incremental growth of USD 78.6 billion, accelerating at a CAGR of almost 4.9% during the forecast period 2022-2028.

In 2021, the outpatient behavioral rehabilitation segment made up the largest share of revenue generated by the behavioral rehabilitation market. On the basis of region, the behavioral rehabilitation market also can be divided into: North America, Europe, Asia-Pacific, Rest of the World (RoW). Among these, North America was accounted for the highest revenue generator in 2021.
