Abstracts

According to Gen Consulting Company, the global carbon black market is set to achieve an incremental growth of USD 5.8 billion, acelerating at a CAGR of almost 4.9% during the forecast period 2022-2028.

This industry report offers market estimates of the global market, followed by a detailed analysis of the process, application, and region. The global market data on carbon black can be segmented by process: acetylene black, channel black, furnace black, lamp black, thermal black. Among these, the furnace black segment was accounted for the highest revenue generator in 2021. The tires and industrial-rubber products segment is estimated to account for the largest share of the global carbon black market.
