## Abstracts

The global logistics outsourcing market was valued at USD 983 billion in 2022 to USD 1,394 billion by 2029, progressing at a CAGR of 5.1% from 2023 to 2029, according to the latest market study results.

The report covers market size and growth, segmentation, regional breakdowns, competitive landscape, trends and strategies for global logistics outsourcing market. Asia-Pacific was the largest contributor to the global logistics outsourcing market in 2022.
