## Abstracts

Pumps are devices that move fluids (liquids or gases), or sometimes slurries, by mechanical action, typically converted from electrical energy into hydraulic energy. Mechanical pumps can be utilized in various applications such as pumping water from wells, water cooling, pumping oil, and heating and cooling objects or systems. According to market research study published by Gen Consulting Company, the market size of the global pumps sector is expected to rise by USD 8 billion with a CAGR of 3.5% by the end of 2028.

The global market data on pumps can be segmented by product: positive displacement (PD) pumps, centrifugal pumps. In 2021, the centrifugal pumps segment made up the largest share of revenue generated by the pumps market. The water and wastewater segment was the largest contributor to the global pumps market in 2021. Based on region, the pumps market is segmented into: Asia Pacific, Europe, North America, Rest of the World (RoW).

The PD pumps market is further segmented into diaphragm pumps, gear pumps, lobe pumps, peristaltic pumps, piston pumps, progressive cavity pumps, screw pumps, vane pumps. Among these, the diaphragm pumps segment was accounted for the highest revenue generator in 2021.
