## Abstracts

Seed, as an important source of food and agriculture, is the backbone of sustainable development as the diversity and the quality of seed are key contributors to sustainable food production and ultimately to ensuring global food security and nutrition. Furthermore, the pulses and oilseeds market has been categorized into canola, pulses, soybean, sunflower, others. Gen Consulting Company research indicates that the soybean segment occupied the largest share of this market in 2021 and is expected to draw the highest demand in coming years. The vegetables seeds market is further divided into brassica, cucurbit, roots and bulbs, solanaceae, others. Globally, the solanaceae segment made up the largest share of the seeds market.
