Sperm separation systems are devices used in assisted reproductive procedures, such as in vitro fertilization (IVF), intrauterine insemination (IUI), and intra-cervical insemination (ICI). These systems are designed to separate motile sperm cells from debris and non-motile sperm cells in a semen sample. Sperm separation systems allow the migration of motile sperm cells from the semen layer into the separation media.
