## Abstracts

The global transplantation and alternatives market is projected to rise by USD 54 billion by 2028, according to a new report by Gen Consulting Company. It is anticipated to expand at a CAGR of 7.4 percent during the forecast period.

The alternatives market is further segmented into orthopedic alternatives, ventricular assist devices (VADs), others. The orthopedic alternatives segment held the largest share of the global transplantation and alternatives market in 2021 and is anticipated to hold its share during the forecast period. Furthermore, the immunosuppressants market has been categorized into anti-proliferative agents, calcineurin inhibitors, m-TOR inhibitors, polyclonal antibodies, T-cell costimulation blocker. In 2021, the calcineurin inhibitors segment made up the largest share of revenue generated by the transplantation and alternatives market. The tissue products market is further divided into heart valves, cornea, orthobiologics, peripheral blood stem cells, skin grafts, soft tissue, vascular grafts. Among these, the peripheral blood stem cells segment was accounted for the highest revenue generator in 2021.
