Sulfuric acid or sulphuric acid, known in antiquity as oil of vitriol, is a mineral acid composed of the elements sulfur, oxygen and hydrogen, with the molecular formula H_2SO_4 . In various concentrations the acid is used in the manufacture of fertilizers, pigments, dyes, drugs, explosives, detergents, and inorganic salts and acids, as well as in petroleum refining and metallurgical processes. According to Gen Consulting Company, the sulfuric acid market in Russia, in terms of volume, is anticipated to progress at a CAGR of 4.1% during the forecast period, 2022-2028.
