Through these subsidiaries, the company offers non-standard auto insurance and management services to its customers. The company distributes its products through managing general agents. It has operations in Bermuda, Barbados, and the US. AOG is headquartered in Hamilton, Bermuda.

The company reported gross written premium of US\$426.3 million during fiscal year ended December 2016 (FY2016), an increase of 10.7% over FY2015. Its net written premium was US\$9.3 million, a decrease of 39.6% over FY2015.
