As of 31 December 2016, the company has proved and probable ore reserves of 28.2 million ounces at 1.74 g/t gold for 1.6 million ounces. Moreover, it has measured, indicated and inferred mineral resources of 67.0 million tonnes at 1.82 g/t gold for 3.9 million ounces. Beadell is headquartered in Perth, Western Australia, Australia.
