Everest is headquartered in Hamilton, Bermuda.

The company reported gross written premium of US\$6,033.9 million during the fiscal year 2016 (FY2016), compared to US\$5,891.7 million representing an increase of 2.4% over FY2015. Its net written premium was US\$ 5,270.9 million in FY2016, an increase of 1.7% over FY2015.
