GIPCL sources natural gas from Gas Authority of India Limited (GAIL), and lignite coal from Vastan and Mangrol-Valia lignite mines. It also provides operational and management services to its gas and lignite based power plants; power plant project management consultancy; testing; commissioning; and troubleshooting services. GIPCL is headquartered in Vadodara, Gujarat, India.
