Its pipeline products include brensocatib, an orally administered reversible inhibitor of dipeptidyl peptidase 1 (DPP1) for treating non-cystic fibrosis (non-CF) bronchiectasis, cystic fibrosis and COVID-19; TPIP, an inhaled formulation of a treprostinil prodrug which is being developed for pulmonary arterial hypertension (PAH), idiopathic pulmonary fibrosis, and PAH associated with interstitial lung diseases. The company through its subsidiaries operates in the US, the UK, the Netherlands, Ireland, Germany, France and Japan. Insmmed is headquartered in Bridgewater, New Jersey, the US.
