The company holds 31% ownership in Evolution Mining, which owns and operates five gold mines located in Cowal in New South Wales; Mt Carlton, Mt Rawdon, and Cracow, in Queensland; and Mungari in Western Australia. It has gold ore reserves of 6.99 million ounces and mineral resources of 14.18 million ounces. The company holds 30% ownership in Endeavor Mining, which operates six mines across Cote d'Ivoire in Agbaou and Ity; Burkina Faso in Hounde and Karma; Mali in Tabakoto, and Ghana in Nzema. The mine has proven and probable reserves of 168 million tonnes (Mt) of gold at 1.81 Au g/t and content 9,758 koz of gold. It has measured and indicated resources of 254 Mt of gold at 1.88 Au g/t and content 15,364 koz of gold. La Mancha is headquartered in Luxembourg.
