The company owns 65% interest in Xingwu Coal Mine that covers a mining area of 11.63 sqkm, while the Jinjiazhuang Coal Mine has a mining area of 6.35 sqkm and Zhaiyadi Coal Mine covers a mining area of 13.91 sqkm. Shougang Fushan has three coal preparation plants with processing capacities of 1.2 million tonnes, 2.1 million tonnes, and 3.0 million tonnes per annum. The company is a subsidiary of Shougang Corporation and is headquartered in Wanchai, Hong Kong.
