ATM drugs that target the cancer cell cytoskeleton are being developed for the treatment of melanoma, prostate cancer and neuroblastoma. SBP drugs that target cancer stem cells are being developed for the treatment of ovarian cancer and glioblastoma. The PI3K inhibitor functions by inhibiting an important signaling pathway which is critical to the development of certain kinds of tumors. The company's product pipeline includes PI3K GDC-0084; Cantrixil (TRX-E-002-1); Trilexium (TRXE-009-1). Novogen is headquartered in New South Wales, Australia.
