The Papua New Guinea Government owns 87.8% of the company and 12.2% is held by the people of Western Province. The company markets its products for smelting markets in various countries including Japan, South Korea, Germany, India, Indonesia and Philippines. OTML is headquartered in Tabubil, PNG.
