The company also offers directors' and officers' liability reinsurance, products' liability reinsurance, and professional indemnity reinsurance. It publishes insurance reviews through its publications such as Asia Insurance Review and Middle East Insurance Review, and directories, including Asean Insurance Directory, Reinsurance Directory of Asia, and Insurance Directory of Asia. Furthermore, the company provides insurance consultancy and management services in China, and manages properties and investments in China. SingRe also organizes conferences and insurance training courses. The company's operations are spanned across Singapore, Malaysia, and other Asian countries. SingRe is headquartered in Singapore, Singapore.

The company reported gross written premiums of SGD169 million during fiscal year ended December 2016 (FY2016), an increase of 31.7% over FY2015. Its net written premiums was SGD50.7 million in FY2016, a decline of 5.1% over FY2015.
