Sohar Aluminium LLC (Sohar Aluminium) is a one of the largest smelters in the Middle East region. Sohar Aluminium is jointly owned by Oman Oil Company, Abu Dhabi National Energy Company PJSC - TAQA and Rio Tinto. The company has the world's longest single potline at 1.2 kms long. The smelter produces metals in three forms: ingots (23.7kg), sows (700kg) and hot metal used by local downstream partners to reduce energy consumption in subsequent processing. The smelter has an annual production capacity of 375,000 tons of aluminum. The company also has a 1,000MW power generation facility. The Sohar Aluminium Power Plant (SAPP) is fuelled by natural gas. SAPP's 75% of output is supplied to the smelter and the remaining 25% of the energy is saved in the reserve by the operator of Omani electrical distribution grid. Sohar Aluminium is headquartered in Sohar, Oman.
