The company principally undertakes the supply of drinking water, wastewater treatment and water recycling services. It supplies 532 million liters of water per day and provides drinking water to more than 1.1 million properties. The company operates a network of 13,870 kilometers of water mains, 91 water treatment works, 188 service reservoirs, 365 wastewater treatment works and 3,243 pumping stations. It generates electricity through various renewable energy sources. The company extracts water primarily from underground sources, which are called aquifers, and remainder from rivers and reservoirs. SWSL provides water and wastewater services across Kent, Sussex, Hampshire and the Isle of Wight. The company operates as a subsidiary of Greensands Investments Limited, and is headquartered in Worthing, West Sussex, the UK.
