The company lead product candidate is Onvansertib (previously known as PCM-075), a first-in-class, 3rd generation, adenosine triphosphate (ATP) competitive inhibitor of polo-like kinase 1 (PLK1) enzyme. It is being developed for treating indications such as Acute Myeloid Leukemia (AML), metastatic Castration-Resistant Prostate Cancer (mCRPC) and metastatic Colorectal Cancer (mCRC), having a KRAS mutation. Onvansertib is being evaluated in three clinical trials, namely, TROV-052, TROV-053 and TROV-054. Trovagene is headquartered in San Diego, California, the US.
