Abstracts

The global Anti-herpesvirus Agent market size is expected to reach \$ 7363 million by 2032, rising at a market growth of 4.9% CAGR during the forecast period (2026-2032).

Anti-herpesvirus Agents, under the drug-based scope, refer to antiviral medicines used to treat or prevent herpesvirus infections. These agents mainly target viral DNA replication, viral DNA polymerase, viral thymidine kinase, the CMV terminase complex, viral protein kinase, or other key steps in viral replication. Representative products include acyclovir, valacyclovir, famciclovir, penciclovir, ganciclovir, valganciclovir, foscarnet, cidofovir, letermovir, maribavir, and amenamevir. Major indications include herpes labialis, genital herpes, herpes zoster, chickenpox, herpetic keratitis, severe HSV/VZV infections in immunocompromised patients, and prevention or treatment of transplant-related CMV infection. Key upstream inputs include guanine analogues, nucleoside analogue intermediates, chiral intermediates, halogenated purine derivatives, phosphonate intermediates, CMV-specific small-molecule intermediates, active pharmaceutical ingredients, excipients, water for injection, packaging materials, sterile filling components, tableting and coating equipment, sterile formulation equipment, and quality-control systems. Major downstream customers include infectious disease departments, dermatology departments, obstetrics and gynecology departments, ophthalmology departments, transplant centers, hematology departments, ICUs, oncology departments, retail pharmacies, online pharmacies, primary care institutions, and public health programs. The industry's overall gross margin is generally estimated at 46%?72%.

The global Anti-herpesvirus Agent market has developed a product structure based on nucleoside analogues, with CMV-specific drugs and new-mechanism therapies serving as high-value supplements. Mature products such as acyclovir, valacyclovir, and

famciclovir remain the foundation of treatment for herpes simplex virus and varicella-zoster virus infections due to their established efficacy, broad dosage-form availability, long clinical use, and sufficient generic supply. In the cytomegalovirus segment, treatment and prevention rely more on ganciclovir, valganciclovir, foscarnet, cidofovir, letermovir, and maribavir, mainly serving organ transplant, hematopoietic stem cell transplant, immunosuppressed, and severe infection patients. Overall, the traditional HSV/VZV drug market is growing steadily, while incremental revenue is increasingly driven by transplant-related CMV prophylaxis, refractory CMV infection treatment, and continued uptake of high-value specialty drugs.

Market growth is mainly driven by the recurrent nature of herpesvirus infections, the rising burden of herpes zoster in aging populations, growth in immunosuppressed patients, development of transplant medicine, and increasing demand for CMV infection management. HSV infection often requires episodic treatment or long-term suppressive therapy, while VZV-related herpes zoster causes a higher disease burden among elderly and immunocompromised populations. CMV infection is an important risk factor in post-transplant infection management. As transplant-center capability improves, CMV monitoring becomes more standardized, and awareness of prophylaxis in high-risk patients increases, the clinical value of specialty drugs such as letermovir and maribavir is becoming more prominent. At the same time, improved access to diagnosis and treatment for common herpesvirus infections in emerging markets will continue to support stable demand for mature drugs such as acyclovir and valacyclovir.

From a product and technology perspective, Anti-herpesvirus Agents will continue to develop toward improved dosing convenience, treatment of resistant infections, lower toxicity, new mechanisms of action, and expanded indications in special populations. Traditional nucleoside analogues will remain widely used, but competition will focus more on dosage-form optimization, medication adherence, cost control, and channel coverage. In CMV treatment, more attention will be given to bone marrow suppression, nephrotoxicity, resistance mutations, drug interactions, and the safety of long-term prophylaxis, while new-mechanism drugs are expected to gain stronger clinical positions in transplant-related infection management. Future product development will place greater emphasis on refractory or resistant infections, pediatric patients, immunosuppressed populations, ocular infections, and long-term suppressive therapy, while improving patient management efficiency through oral formulations, less frequent dosing, and better safety profiles.

Industry development is still challenged by price competition for mature products, generic substitution, reimbursement pressure, resistance risk, difficulty in validating

clinical endpoints, and payment pressure for high-priced specialty drugs. Traditional products such as acyclovir, valacyclovir, and famciclovir are highly genericized in most countries, so competition increasingly depends on quality consistency, cost control, channel coverage, and dosage-form portfolios. Although CMV and transplant infection drugs have higher unit prices, their patient base is relatively limited and depends strongly on viral-load monitoring, transplant-center coverage, specialist education, and reimbursement capacity. Future market competition will focus more on high-end CMV drugs, resistant and refractory infection treatment, new-mechanism HSV/VZV therapies, global registration capability, specialty-channel service capacity, and accumulation of real-world clinical evidence.
