The software assists with calculating and collecting permit fees and generating reports. Permits include building permits, land use permits, peddler permits, activity permits, and more. Municipalities spend money on these types of systems because they are revenue generators and players often sell the software under the "Community Development" heading. While a few players offer systems that only do permitting, most vendor software also supports business licenses as well.
