# **Abstracts**

The global Tax Advisory market size is expected to reach \$ 58600 million by 2029, rising at a market growth of 5.4% CAGR during the forecast period (2023-2029).

Global tax advisory providers is mainly located in North America, Europe and Hong Kong, China, with key companies including Deloitte, EY, PwC, KPMG, BDO, RSM International and Grant Thornton. The top three firms account for over 30% of the market share, with Deloitte being the largest firm with 11% of the share. In terms of applications, private companies have the largest market share with 45%, while listed companies have 40%.
