The cloud-based segment accounted for approximately 60% of the market share in 2023, highlighting its dominance. This trend can be attributed to the alignment of cloud solutions with modern IT infrastructure and service delivery requirements. As businesses increasingly transition operations to the cloud, the demand for flexible, scalable, and accessible security solutions has grown. Cloud-based DPI offerings allow organizations to monitor and analyze network traffic without the limitations of on-premises hardware, making them attractive to companies with distributed workforces and varied operational landscapes.

In the United States, the deep packet inspection and processing market represented 73.5% of the overall revenue in 2023, with projections indicating it will reach around USD 33.5 billion by 2032. The U.S. boasts a highly advanced IT infrastructure, including a wide array of data centers, cloud service providers, and telecommunications networks. This robust ecosystem supports the integration of sophisticated DPI solutions, enabling organizations to efficiently manage network traffic, bolster security measures, and enhance overall network performance.
