The market is projected t%li%grow at a notable CAGR of 15.5% from 2025 t%li%2030. In addition, Contract Research Organizations (CROs) are witnessing sustained demand for clinical trial services as pharmaceutical firms invest heavily in trial execution, further boosting the adoption of decentralized trial solutions, remote monitoring technologies, and Al-driven analytics.

Based on clinical trial phases, the phase III segment held the largest market share of 53.39% in 2024 and is anticipated t%li%be the fastest-growing segment over the forecast period due t%li%its critical role in determining the safety and efficacy of new treatments.

Based on end use, the pharmaceutical and biotechnology firms segment held the largest market share in 2024, driven by their substantial involvement in clinical research and drug development.

North America dominated the market with a revenue share of 43.59% in 2024, owing t%li%the region's advanced healthcare infrastructure and a supportive regulatory environment guided by the FDA and Health Canada encourage the adoption of digital solutions that improve trial efficiency and regulatory compliance.
