U.S. Law Enforcement PPE Market Growth & Trends

The U.S. law enforcement PPE market is expected to reach USD 1.18 billion by 2030, according to a new report by Grand View Research, Inc., expanding at a CAGR of 5.0% in the forecast period. Surging expenditure on protective gear for law enforcement personnel is significantly boosting the market growth.

The use of personal protective equipment is rising to minimize exposure to hazards during active duty. This equipment is designed to offer protection against serious injuries from close contact with chemical, physical, or radiological hazards. The rising importance of on-duty safety precautions and safety gear is likely to propel the market growth in the forecast period.

Additionally, the number of active law enforcement personnel is expected to rise in the forecast period. Due to the increasing rate of violent crimes, assaults, and robberies catapulted by a surge in instability and distress, police and other law enforcement recruitment is expected to rise. This is also expected to facilitate the need for personal protective equipment.

Moreover, continuous increase in the annual budget by the government is expected to



facilitate the expenditure on PPE and drive the growth of the market. For instance, for the financial year 2023, the budget provides USD 1.97 billion in funding for state and local enforcement, an increase of 12% over the year 2022.

The COVID-19 outbreak had a positive impact on the spending on personal protective equipment by the country's law enforcement such as local police, tactical forces, and state police. Demand for face shields, masks, protective clothing, hand, and eye protection equipment experienced a significant increase to protect during riot situations and from COVID infection.

Companies in the industry are actively in joint ventures, mergers and acquisitions, product innovation, and new product launches to increase market penetration. Most prominently key players are investing in research of lightweight and high-strength materials to produce effective and comfortable gear for tactical work.

#### U.S. Law Enforcement PPE Market Report Highlights

The protective clothing segment dominated the market accounting for a 39.6% share in 2021 owing to the high spending on high-visibility safety apparel, body vests, coveralls, etc.

Eye and face protection segment is expected to grow at a significant CAGR of 6.5% in the forecast period attributed to the rising product development with artificial intelligence.

Respiratory protection is expected to grow at a significant rate over the forecast period due to increasing demand for masks and respirators during rising riots and public violence.

Hi-Vis clothing segment of protective clothing accounted for a significant share in 2021 owing to the high demand and use by the fire department, first respondents, traffic police, and tactical forces.

In March 2021, Revision announced a new collection of eyewear in the U.S. market, The Honor Collection for law enforcement personnel with enhanced laser protection.
