Abstracts

This study covers the world outlook for armored fighting vehicles across more than 190 countries. For each year reported, estimates are given for the latent demand, or potential industry earnings (P.I.E.), for the country in question (in millions of U.S. dollars), the percent share the country is of the region, and of the globe. These comparative benchmarks allow the reader to quickly gauge a country vis-à-vis others. Using econometric models which project fundamental economic dynamics within each country and across countries, latent demand estimates are created. This report does not discuss the specific players in the market serving the latent demand, nor specific details at the product level. The study also does not consider short-term cyclicalities that might affect realized sales. The study, therefore, is strategic in nature, taking an aggregate and long-run view, irrespective of the players or products involved.

In this report we define the sales of armored fighting vehicles as including all commonly understood products falling within this broad category, such as main battle and light tanks; armored personnel carriers; infantry fighting and mobility vehicles; reconnaissance, improvised fighting, amphibious, assault breacher, air defense, and armored recovery vehicles; armored bulldozers; armored vehicle-launched bridges; and products that contain assault guns, mortar carriers, multiple rocket launchers, and tank destroyers, irrespective of product packaging, formulation, size, or form. Companies participating in this industry include BAE Systems, General Dynamics, Iveco, JSC Rosoboronexport (Rostec State Corporation), Lockheed Martin, MITSUBISHI Heavy Industries, Northrop Grumman, Oto Melara, Raytheon, and Rheinmetall AG. In addition to the sources indicated, additional information available to the public via news and/or press releases published by players in the industry was considered in defining and calibrating this category. All figures are in a common currency (U.S. dollars, millions) and are not adjusted for inflation (i.e., they are current values). Exchange rates used to



convert to U.S. dollars are averages for the year in question. Future exchange rates are assumed to be constant in the future at the current level (the average of the year of this publication's release in 2024).
