# **Abstracts**

This study covers the world outlook for medical power supplies across more than 190 countries. For each year reported, estimates are given for the latent demand, or potential industry earnings (P.I.E.), for the country in question (in millions of U.S. dollars), the percent share the country is of the region, and of the globe. These comparative benchmarks allow the reader to quickly gauge a country vis-à-vis others. Using econometric models which project fundamental economic dynamics within each country and across countries, latent demand estimates are created. This report does not discuss the specific players in the market serving the latent demand, nor specific details at the product level. The study also does not consider short-term cyclicalities that might affect realized sales. The study, therefore, is strategic in nature, taking an aggregate and long-run view, irrespective of the players or products involved.

In this report we define the sales of medical power supplies as including all commonly understood products falling within this broad category, such as programmable, uninterruptible, and high and low voltage power supplies; power supply devices used for positive airway pressure (PAP), ventilator, oximeter, nebulizer, oxygen concentrator, and portable inhaler respiratory equipment; power supply devices used for x-ray, computed tomography (CT), magnetic resonance imaging (MRI), ultrasound, and positron emission tomography (PET) radiology equipment; power supply devices used for electrocardiogram (ECG), electroencephalogram (EEG), blood gas analyzer, and anesthesia, blood pressure, and blood glucose monitoring equipment; power supply devices for neurosurgery, plastic surgery, thoracic surgery, cardiovascular surgery, and orthopedic surgery devices; and alternating current to direct current and direct current to direct current power supplies, irrespective of product packaging, formulation, size, or form. Exchange rates used to convert to U.S. dollars are averages for the year in question. Future exchange rates are assumed to be constant in the future at the current level (the average of the year of this publication's release in 2024).
