Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers frozen vegetables as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for frozen vegetables is 3114114. It is for this definition that aggregate latent demand estimates are derived. Frozen vegetables is specifically defined as follows:

3114114 FROZEN VEGETABLES

31141141 Frozen vegetables (asparagus, green beans, lima beans, broccoli, brussels sprouts, carrots, cauliflower, green peas, and spinach)

31141142 Frozen vegetable combinations (succotash, peas and carrots, mixed vegetables, vegetables with pasta, etc.)

31141143 Frozen French_fried potatoes



31141144 Other frozen potato products (patties, puffs, etc.)

31141145 Frozen sweet cut and cob yellow corn

31141146 Frozen southern greens, onions, and other frozen vegetables

31141142A1 Frozen vegetable combinations (succotash, peas and carrots, mixed vegetables, vegetables with pasta, etc.)

31141143B1 Frozen French_fried potatoes

31141144C1 Other frozen potato products (patties, puffs, etc.)
