Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers new parts for exhaust systems as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for new parts for exhaust systems is 3363993. It is for this definition that aggregate latent demand estimates are derived. New parts for exhaust systems is specifically defined as follows:

33639931 Exhaust system parts, new

3363993101 Exhaust system mufflers (including standard, sports or glass pack) and resonators, new, for motor vehicles

3363993104 Exhaust system pipes, including exhaust, intermediate, connecting, crossover, tail, and side pipes
