Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers non-load and load-bearing iron, steel, and aluminum studs as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for non-load and load-bearing iron, steel, and aluminum studs is 332322F. It is for this definition that aggregate latent demand estimates are derived. Non-load and load-bearing iron, steel, and aluminum studs is specifically defined as follows:

332322F METAL STUDS, NONLOAD AND LOAD_BEARING (IRON, STEEL, AND ALUMINUM)

332322F1 Metal studs, nonload and load_bearing (iron, steel, and aluminum)

332322F101 Metal studs, nonload_bearing (iron, steel, and aluminum)
