Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers outboard wood and metal motorboats excluding sailboats and lifeboats as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for outboard wood and metal motorboats excluding sailboats and lifeboats is 33661211. It is for this definition that aggregate latent demand estimates are derived. Outboard wood and metal motorboats excluding sailboats and lifeboats is specifically defined as follows:

33661211 Outboard wood or metal motorboats, including commercial and military (except sailboats and lifeboats)

3366121101 Outboard wood or metal runabouts

3366121104 Outboard wood or metal utility boats



3366121107 Outboard wood or metal pontoon boats

3366121111 Outboard wood or metal bass boats
