Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers particleboard made from wood products produced at the same location as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for particleboard made from wood products produced at the same location is 3212191. It is for this definition that aggregate latent demand estimates are derived. Particleboard made from wood products produced at the same location is specifically defined as follows:

3212191 Particleboard, produced at this location

32121911 Particleboard, industrial, including commercial and shelving, made from particleboard produced at the same location

32121912 Particleboard, non_industrial, made from particleboard produced at the same

location

3212191111 Particleboard, industrial, including commercial and shelving, made from particleboard produced at the same location

3212191221 Particleboard, flooring, including underlayment and manufactured (mobile) home decking, made from particleboard produced at the same location

3212191291 Other particleboard, including stepping, siding, sheathing, and door core, made from particleboard produced at the same location
