## Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

In this report we define the sales of pediatric interventional cardiology as including all commonly understood products and/or services falling within this broad category, such as atrial septal defect (ASD), patent ductus arteriosus (PDA), ventricular septal defect (VSD), and patent foramen ovale (PFO) closure devices, transcatheter heart valves, atherectomy devices, catheters, guidewires, balloons, stents, and intravascular ultrasound (IVUS), optical coherence tomography (OCT), and near infrared spectroscopy (NIRS) imaging techniques, irrespective of product packaging, formulation, size, or form.
