## **Abstracts**

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers poultry and livestock feed excluding feed for chickens, turkeys, cattle, and swine as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for poultry and livestock feed excluding feed for chickens, turkeys, cattle, and swine is 311119M1. It is for this definition that aggregate latent demand estimates are derived. Poultry and livestock feed excluding feed for chickens, turkeys, cattle, and swine is specifically defined as follows:

311119M1 Other poultry and livestock feed

311119M111 Other poultry complete feed (duck, etc.)

311119M121 Other poultry feed supplements and concentrates (duck, etc.)
