Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers power circuit breakers as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for power circuit breakers is 33531311. It is for this definition that aggregate latent demand estimates are derived. Power circuit breakers is specifically defined as follows:

33531311 Power circuit breakers, all voltages

3353131100 Power circuit breakers, all voltages

3353131101 Power circuit breakers (sold separately) for use in metal_clad switchgear (oil and oil_less), over 1,000 volts

3353131103 All other power circuit breakers (sold separately)

3353131129 Parts for all other power circuit breakers
