## Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers power and distribution transformers excluding parts as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for power and distribution transformers excluding parts is 3353111. It is for this definition that aggregate latent demand estimates are derived. Power and distribution transformers excluding parts is specifically defined as follows:

33531111 Distribution transformers (except general\_purpose), overhead type, single\_phase, liquid\_immersed, 500 kVA and smaller (except parts)

33531113 Other distribution transformers (except general\_purpose), including network transformers, single\_phase, and liquid\_immersed (all voltages) (except parts)

33531114 Small conventional and power transformers, single\_ and three\_phase (all voltages), primary and secondary unit substations

33531115 Large liquid\_immersed power transformers with and without load\_tap\_changing

335311101 Distribution transformers (except general\_purpose), overhead type, single\_ phase, liquid\_immersed, 500 kVA and smaller (except parts)

335311204 Distribution transformers (except general\_purpose), compartmentalized pad\_ mounted, single\_phase, liquid\_immersed, 500 kVA and smaller (except parts)

335311307 Distribution transformers (except general\_purpose), subsurface and subway types, single\_phase, liquid\_immersed, 500 kVA and smaller (except parts)

335311311 Distribution three\_phase transformers (except general\_purpose), liquid\_ immersed, all voltages, 500 kVA and smaller (except parts)
