Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers power roof ventilators and parts as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for power roof ventilators and parts is 33341201. It is for this definition that aggregate latent demand estimates are derived. Power roof ventilators and parts is specifically defined as follows:

33341201 Power roof ventilators and parts

3334120101 Axial and propeller type power roof ventilators, except parts

3334120104 Centrifugal type power roof ventilators, except parts

3334120107 Parts for power roof ventilators
